

Best Practice Sleep and Rest Audit Tool for Education and Care Settings

The Best Practice Sleep and Rest Audit Tool may be used to support critical reflection on current sleep and rest practices and to identify best practice control measures to inform the service’s risk assessment and sleep and rest policies and procedures. Approved providers will need to consider how often they use the audit tool to ensure regular review of their service’s practices and how the audit tool informs the service’s policies and procedures.

The Best Practice Sleep and Rest Audit Tool is not a risk assessment tool and providers should refer to the [ACECQA Sleep and Rest Risk Assessment Template](#) to support the required annual risk assessment.

The term infant is used to refer to children under two years of age.
